A. Organization & Management

1. Introduction

Based on the Ordinance of the Minister of Education and Sports No. 116, dated 13.03.2017 "On the opening of the main unit and the institutional re-organization of Epoka University", starting from the 2017-2018 academic year, the Department of Law has been established as part of the Faculty of Law and Social Sciences. It started its academic activities during the 2018-2019 academic year by building upon the solid academic tradition of EPOKA University.

The mission of the Department of Law, through the integrated second cycle program in Law, is to prepare specialists in the field of law, future qualified leaders to contribute in the advancement of justice and the welfare of society; capable to engage in position in the judiciary, juridical bodies, prosecution, advocacy, notaries, bailiff, arbitration, central and local state administration, various institutions of state authorities, as well as in private sector.

Our integrated second cycle study program is the only bilingual Law program in the country with English and Albanian as languages of instruction, and it has a strong emphasis on International and EU Law. The curriculum of the program has an inter-disciplinary approach with courses offered in collaboration with the other Departments from the Faculty of Law and Social Sciences as well as from the Faculty of Economics and Administrative Sciences.

Our students will have the opportunity to be participate in numerous mobility programs in the framework of Erasmus+ program as well as other bilateral agreements. They will also have the chance to experience the rich campus life at EPOKA and benefit from the internship programs. The Department is committed to be an active unit which aims to resolve legal, social, economic, domestic and international political problems that are of a particular interest to society.

2. Study programs offered by the Department.

Department of Law offers only one study program, the integrated study program in Law.

Pursuant to the Ordinance of the Minister of the Education, Sports and Youth No. 412, dated 18.09.2017, the Integrated second cycle study program in Law to be offered by the Department of Law under the Faculty of Law and Social Sciences of EPOKA University has been licensed.

The Integrated second cycle study program in Law is a full-time study program, with a duration of 5 (five) academic years with 300 ECTS, and it is a bilingual program with Albanian and English as languages of instruction.

The study program enrolled its first cohort during the 2018-2019 academic year.

The integrated second cycle study program in Law offers to students the opportunity to gain analytical capacities and the basic concepts of law, legal terminology, legal theories and necessary procedures to deal with the theoretical and practical problems in the field of law.



The integrated second cycle study program in Law offered by our department is in full compliance with the requirements of the Albanian Higher Education Law and after the completion of this 5-year program, students are conferred a Master of Science degree.

Students who graduate from the integrated second cycle study program in Law can become judges, prosecutors, lawyers, notaries, state lawyers, private or state bailiffs, as well as lawyers in the central and local state administration, after they have completed the state exam in law.

Niuton Mulleti was born in Shkodër, Albania, in 1981. With a Bachelor and Master's degree in International Relations awarded respectively by Gazi University in Ankara, Turkey, and Central European University in Budapest, Hungary, from 2004 to 2008, he worked at the (Central) Bank of Albania, firstly as a Specialist and then as Head of Division coordinating the process of the approximation of Bank of Albania's legislation and procedures with the acquis communautaire. In 2016 he completed his PhD degree in International Relations and Diplomacy at the HEIP-Centre d'Études Diplomatiques et Stratégiques (CEDS) in Paris, France.

Since 2008, Mr. Mulleti has been working at EPOKA University in Tirana, Albania, initially as a Lecturer at the Department of Political Science and International Relations, and since 2017, as Acting Head of the Department of Law. His research interest areas are EU Law, EU Foreign and Defence Policy and Theories of European Integration.

Prof. Dr. Endri PAPAJORGJI is a lawyer, legal expert and well-known lecturer in the field of law with over 15 years of experience. Prof. Endri Papajorgji has completed his higher studies (Bachelor-Master-PhD) in Law at "Karl Franzens Universität Graz", Austria and has earned the academic title "Associate Professor" from the Faculty of Law, University of Tirana in May 2015. In June 2022 he earned the academic title "Professor Doctor" from the Faculty of Law, University of Tirana.

Prof. Endri Papajorgji has carried out scientific research work at the University of Graz, Maribor, Vienna, Leuven, Salzburg, Zagreb, Ljubljana, Munich, Regensburg, Skopje, Tetova, Pristina, etc., as well as at the EU Institutions in Brussels and Luxembourg. Prof. Endri Papajorgji has worked



as lawyer at several international and local legal offices (Vienna, Graz, Tirana), as well as Professor at the "Karl Franzens Universität Graz" Austria and Professor at several public and private universities in Albania. His areas of scientific research where he also lectures as a "Professor" are focused in the field of civil law, including the following subfields:

- Right of Arbitration;
- Private international law;
- International and European commercial law;
- International and Albanian competition law;
- EU obligation law;
- Protection of personal data;
- Digital Law and cyber security;

From 2004 onwards, he is a legal expert and then Legal Director of the Scientific Institute "International Institute for Private, Commercial and Competition Law" based in Graz, Austria.

Prof. Endri Papajorgji has been elected Dean of the Faculty of Law of Tirana Business University from 2014 - 2022 and Deputy. Rector since October 2015 – October 2022.

Prof. Endri Papajorgji has worked as Cabinet Advisor in 2022 at the Albanian High Council of Prosecution.

During the period 2007 - onward, he was part of dozens of working groups in the framework of the drafting of legislation in the field of law and education, as well as a legal expert in several projects financed by USAID, OSCE, UNDP, etc.

Prof. Endri Papajorgji has published 8 scientific books, 2 of which in Germany and 6 in Albania. He has published over 150 scientific articles in international scientific conferences and journals with a total of more than 6000 pages in the form of scientific monographs, scientific articles, textbooks, publications in proceedings with ISBN and ISSN, book chapters, opinions and legal drafts, etc.

Prof. Endri Papajorgji is a Member of the Albanian National Chamber of Advocacy, Member of the Albanian National Chamber of Mediation, Executive Director of the International Institute for Private, Commercial and Competition Law, Member of Uni Graz Network, Editor-in-Chief of the international scientific journal "Academic Journal of Business, Administration, Law and Social Sciences", Board Member of the "Albanian Social Economic Review", etc.

3. IT Resources, Physical Infrastructure and Library Resources

The Department of LAW is entitled to use all the resources and infrastructure of Epoka University.



The Information and Communication Technologies Coordinating Office (ICTCO) provides informatics services needed in the University. It plans the informatics infrastructure of the University, provides its security and ensures the continuation of its functions. ICTCO works on the project for effective, legal and extensive usage of the informatics services for students and personnel and provides the following services:



Teaching Services:

- Turnitin software helps users to understand and avoid plagiarism and develop their understanding of how to cite sources as part of an academic argument. ICTC office manages the users and trains the staff about how to use Turnitin.
- Learning Management System (LMS) A service based on Moodle offered for students and instructors in order to access, coordinate and organize course materials online. Students and instructors can log in to LMS using the provided official email account.



- Library Automation System (Koha) Koha is an open-source Integrated Library System in use today by hundreds of libraries worldwide. Koha is web based, so there is no software to install on desktop computers. Users can check the books online and reserve them via the web. Its features are more than enough to manage the Epoka Library effectively and efficiently.
- **DSpace** The institutional repository of Epoka University: DSpace is an open-source repository software package typically used for creating open access repositories for scholarly and/or published digital content. The proceedings of the conferences which are organized by Epoka University can be accessed from this repository. Epoka University is the only university who has digital repository in Albania (http://repositories.webometrics.info/en/Europe/Albania). We also give services to other international journals publications to publish their (http://dspace.epoka.edu.al/handle/1/1378) in our digital repository.

Google Services:

- Webmail (Google account) –Epoka University is using Google Apps for Education services and all students and academic and administrative staff are provided with an email address under epoka.edu.al domain which is a Google account. Besides official communication, which is done through this email address, this account can be used for authentication to other online systems offered by university.
- Google Classroom A more interactive service offered by Google as part of Google Apps for education in order to access, coordinate and organize course materials on cloud. By using Google Classroom, course materials can be integrated with other Google services where assigned users can collaborate. Students and instructors can access this service using the provided account.

Education Information System (Curriculum) – a website containing information related to study programs, curriculum and course syllabuses.

Smart Card: All students and staff are provided with Smart Card identification cards. The Smart Card is put as an e-ID application at three buildings, two PC labs, one Electronics Lab, and campus gate entry turnstiles and barriers. The e-wallet application is active for staff but has not started yet for students.

Help Desk: ICTCO is also responsible for the maintenance of personnel and PC Lab computers in respect to software and hardware. Its staff monitors the personal computers within the frame of distribution of duty and authority and brings the issues to a conclusion. At the same time, ICTCO plans servers and cabling services of the University. Staff can open tickets via help.epoka.edu.al for their ICTCO-related problems and follow the process from here. You can share your opinions on every subject related to information technologies and informatics with help@epoka.edu.al and you can also write your complaints and suggestions for a better campus life.

Software Opportunities

Epoka University has a subscription to the Microsoft Program which is called Dream Spark. It supports technical education by providing access to Microsoft software for learning, teaching and



research purposes. Epoka University also provides Office 365 accounts to all staff and students, which includes all office applications for free.

Network:

- Wireless: Epoka University provides wireless internet connection to all Epoka members on the campus. As ICTCO, we ensure that the wireless signal is strong and covers everywhere on campus.
- Wired: Besides wireless, there are three PC labs, one Civil Engineering lab, one Electronics lab, one PhD study room and a library where PCs serve students and staff with wired internet. In the Epoka Library and one of the classrooms, there are plug and use stations next to each table where students and staff can use wired internet and electricity for their laptops.
- **Digital Signage:** There are four TVs on campus, which are used to inform Epoka members about the latest news and announcements.

Epoka Interactive Systems (EIS)



Recognizing the needs of campus community, Epoka has made a strategic decision to replace its aging, cumbersome, and vendor-supported student, instructors, and staff systems with a modern, nimble and effective internally built system that includes admissions, enrolment, registration, financial aid, student, instructor, and staff accounts, and advising in one platform.

EIS is developed by ICTCO at Epoka University. From the user interface, EIS is an online interactive system where users can log in using the provided official email account. It is a modular system organized by roles and respective units at the university and the information is stored in a

centralized database. All users have access to their personal information, can update general details and CV and they can manage job related tasks and activities according to their role and job position.

- Students: Students in their profile can access their personal information and information related to their study program. Course registration is done through the system and after that, students can view the ongoing academic activity of the registered courses during the semester. They can check attendance, exam dates, interim grades and final grades. Also, in the system, they can access the program curriculum, transcript, grade calculation, weekly schedule, requests and notifications. The EIS prompts students when they are in the "warning zone" for financial or academic issues. It empowers students to create course plans to ensure timely graduation.
- Instructors: Academic staff, including full-time and part-time lecturers can have access to their courses assigned in the current semester and can also view previously assigned courses. Lecturers can update the syllabus, complete student attendance, assign and finalize grades. Advisor lecturers can have access to academic information of the students assigned for advisory and they can approve student course registration.
- Coordinators: The opening of courses according to course appointment in each semester is
 done by department coordinators and approved by faculty coordinators. Coordinators can
 monitor the academic activity of the lecturers under the respective department.
- Admissions and Registrar's Office: Admissions Office enters all pre-registered student information and assigns scholarships. After the student has completed the registration, all the related information entered by the Admissions office is managed by the Registrar's office.
- **Finance:** Finance office can manage and follow up all student financial information related to tuition fees and scholarship.
- **Human Resources:** Human resources office can manage all staff information data and assigns roles and job position for each staff.
- **Curriculum:** a website containing information related to study programs, curriculum and course syllabus.

All users have access to their personalized reports according to their roles and respective units. Faculties and units are liberated from tedious manual tasks. EIS supplies them with new and most updated information that will empower them to make informed decisions based on data.

EIS can be continuously updated with new modules according to the university's needs. EIS can be accessed via: https://eis.epoka.edu.al and users can log-in by their Epoka Mail account credentials.

Physical Infrastructure

The campus extends over a total area of 67,000 m 2. Through the year, students and lecturers have used different classes in D- Building. This building has a modern infrastructure and a central heating and cooling system. The classrooms are equipped with video projectors and smart boards



that enable the normal conduct of the learning process. In addition to classes, there are plenty of recreational facilities for students such as cafeterias, libraries, internet cafés, facilities for the Student Council and student clubs, sports facilities, etc.

For departmental activities and events, the LAW Department extensively uses the meeting rooms as well as the Conference Hall, which has a capacity of 99 people. The conference Hall is used for the PIR Department's social, cultural and various national and international forums and conferences.

Library

The EPOKA University Library, which is located on the first floor of A- Building in the EPOKA University Campus, was founded to support the education and research activities of the university by providing and organizing the needed documents. With its 100-seating capacity, our library has a 400 square meters area of use. Our University Library is composed of entrance, book and reading hall. In the entrance, there is a check out desk. The periodicals, including the exhibition of new arrivals, are also shelved in this section. The reading hall is equipped for students to study and to do research. EPOKA University is a member of the Balkan Libraries Union which was founded on 29 July 2009 with the participation of 10 institutions from 6 Balkan countries. Our library collection is enriched by purchases and donations. The books to buy are chosen in accordance with the needs and requests of the students, administrative and academic staff. Under the Department of Library and Documentation, the library has a total of about 7500 printed books.

Digital Databases

EPOKA University has full membership in JSTOR, a shared digital library created in 1995 that includes more than 2,000 academic journals. JSTOR was founded to help libraries and academic publishers transition their activities from print to digital operations, to expand access to scholarly content around the world and to preserve it for future generations. Every member of EPOKA staff can access JSTOR's collections by going tohttp://www.jstor.org/ and searching or browsing for content.

Using the Library

Our library works on an open shelf system enabling you to reach the books directly. The books in the open shelves are topically sorted in the book hall according to LC classification method. To find the book you are looking for, you should follow these steps:

- 1. Through the catalog search computers in the library; you can search author name, book name, and publisher, topic, or keyword areas.
- 2. To get the book, you can go to the shelves with the classification and location numbers of the books appearing on the screen as a result of your search.

Regulations

Students of Associate Degree, Bachelor's Degree and Master Students and academic and administrative personnel are the members of the library. They can borrow library materials in accordance with the rules. Researchers coming from outside the university are not lent books, they are only allowed to use and copy the materials in the library. Thesis Title: Joint Stock Company and Its Legal Regulation According to Albanian Legislation in

Comparison with Italian Legislation. Supervisor: Dr. Gelanda Shkurtaj

Thesis Summary: A joint stock company is a type of organization that allows efficient accumulation and distribution of capital, as well as limited liability for shareholders. Legal regulations are essential to ensure the proper functioning of joint stock companies and the Albanian and Italian legal systems offer different approaches to their regulation. This paper aims to analyze the legal framework of joint stock companies in Albania and Italy, comparing and identifying their main characteristics and regulatory differences. The study first provides an overview of the concept of the joint stock company and its history, followed by a detailed analysis of the legal regulation of joint stock companies in Albania and Italy. The analysis includes a comparison of the formal requirements for the creation and operation of a joint stock company, the role and responsibilities of shareholders, the governance structure and the regulatory framework for mergers and acquisitions. The study also examines the legal remedies available to shareholders and the mechanisms for protecting the rights of minority shareholders. Finally, the paper assesses the effectiveness of the legal framework in each country and identifies potential areas for improvement. The study highlights important differences in the legal regulation of joint stock companies in Albania and Italy, where the Italian system offers more extensive and detailed regulations. However, the Albanian legal system has made significant progress in recent years, aligning the legal framework with the standards of the European Union.

The findings of this study may be of interest to practitioners, policy makers and researchers interested in the comparative analysis of the legal framework for joint stock companies.

Thesis Title: The Phenomenon of Domestic Violence in Albania and the Effectiveness of Legislation & Institutions in its Prevention.

<u>Thesis Summary</u>: Domestic violence is a widespread issue that affects individuals, families and communities around the world and this phenomenon is also widespread in Albania. This study focuses on the understanding of the level of domestic violence in Albania and the evaluation of the effectiveness of existing legislation and institutions in the prevention and treatment of this issue. Domestic violence includes various forms of abuse that occur within intimate relationships, imposing physical, psychological, sexual, and economic risks on its victims. Criminogenic factors, such as cultural norms, socio-economic inequalities and gender inequalities, contribute to the continuation of this problem within Albanian society.



In order to address the research questions on the extent of the phenomenon of violence in Albania and the measures taken, the study will use a mixed methods approach, combining qualitative and quantitative methods. The research will begin with a thorough review of existing literature, including academic journals, legal texts, government reports and relevant publications on domestic violence in Albania. Next, primary data will be collected through public reports from responsible institutions in Albania, such as law enforcement agencies, social services and courts, focusing on documented cases of domestic violence and their outcomes. Also, secondary data will be collected, such as statistical information and reports from non-governmental organizations, to provide quantitative knowledge on the prevalence and trends of domestic violence in the Albanian context. The study will critically evaluate the provisions and measures of the law aimed at preventing and treating domestic violence, as well as its implementation and effectiveness in practice. In addition, the research will compare Albanian legislation no. 9669, dated 18.12.2006 on "Measures against Violence in Family Relations in Albania" with relevant international standards and best practices to identify areas for improvement. The paper also investigates the fundamental factors that contribute to the spread of domestic violence in Albania. By examining social, cultural and economic aspects, the study aims to identify the root causes and risk factors associated with domestic violence.

Based on these insights, the study will provide recommendations for strengthening the legal system, increasing support services, and promoting awareness and education to effectively prevent domestic violence.

Thesis Title: Comparison of Italian and Albanian Legislation on the Institution of Inheritance.

Thesis Summary: This study will deal with the comparison of Italian and Albanian legislation on the institution of inheritance. The institution of inheritance is one of the main aspects of inheritance law and is essential in the distribution of a person's assets after his death. This topic aims to analyze and compare the Italian and Albanian legislation regarding the institution of inheritance, focusing on the basic principles of inheritance law, such as the birth of inheritance, the determination of heirs, the obligations of heirs and the procedures for pursuing inheritance. In comparison to the Italian legislation, the Albanian legislation on the institution of inheritance has essential changes, such as the rules of the transfer of property, the limitations and obligations of the heirs and the procedures for the initiation and decision of the legal inheritance.

A detailed analysis of the Italian and Albanian legislation regarding the institution of inheritance can help to identify the differences and similarities between them and to evaluate the effectiveness of the legislation in the division of property and the rights and obligations of the heirs.

In conclusion, this topic aims to bring recommendations for the improvement of the Albanian legislation, when superiority over the institute of heritage is evidenced compared to the Italian one.

Thesis Title: The Right to Privacy in Albania. Its Compliance with the EU GDPR and Current

Challenges.

<u>Thesis Summary:</u> The right to privacy is paramount human rights nowadays. A special attention has been paid by the European Union in the respective field of data protection which with the



development of technologies has faced significant challenges. Specifically, Albania is a candidate state in the European Union since 2014. The right to privacy in Republic of Albania is enshrined in the Article 35 of the Constitution of the Republic of Albania, while the law governing the data protection is Law No. 9887 "On the Data Protection". However, in Albania a series of leaks that resulted in serious breaches of data protection happened from 2021 - 2022, events that further fueled suspicion regarding the cause of these occurrences. Is it the weak legal framework or is it the weak implementation of laws?

Consequently, the thesis aims to answer these questions by studying the development of the right to privacy in Albania during the transition to a pluralistic democratic country and its implementation in the Albanian legal framework. Since European Union is a structure that has dealt with data protection challenges and Albania has an obligation to harmonize its laws in accordance to EU "acquis communautaire" an analysis of the Albanian legislation is conducted in comparison to the European Union GDPR.

The study displays a strong legal framework in Albania regarding the protection of the right to privacy and quite a satisfactory level of harmonization. However, the differences diminished the Albanian's level of protection in a digitalized era, a gap that will positively be solved with the implementation of the New Draft Law that Albania will adopt. Regarding the breaches in Albania, issues are concluded regarding the implementation of laws and the lack of professionals in the fields of security and preventive mechanisms provided by law. In this case the comparative studies with the European Union situation have underlined ongoing issues even in the European Union therefore the breaches and cyber-crimes in Albania are not a direct result of weak laws or weak implementation but they adhere as a global challenge of this technologized century.

Thesis Title: Dissolution of Marriage and Division of Property.

Supervisor: Dr. Eglantina Farruku

<u>Thesis Summary:</u> This thesis examines the legal framework related to the dissolution of marriage and the division of property in Albania. It provides an overview of the applicable laws, procedures and principles governing the dissolution of marriages in Albania, with a particular focus on the division and distribution of marital assets and liabilities. The paper explores the various approaches to the division of wealth, including the principles of equitable division, equitable distribution and the consideration of various factors in determining a fair and effective distribution under the law. Furthermore, it analyzes the role of the courts in overseeing the process and resolving disputes related to the dissolution of marriage and the division of property.

The study highlights the main considerations and challenges faced by individuals seeking divorce in Albania and provides insight into the legal implications of property division within the context of marriage dissolution.

Thesis Title: A Legal Analysis of the Institute of Prescription in International Criminal Law and

Albanian Legislation.

Supervisor: Dr. Alba Gërdeci

<u>Thesis Summary:</u> The prescription of criminal liability in international law is a complex and controversial issue that requires careful analysis. The statute of limitations refers to the time frame within which a criminal offense can be prosecuted or punished. This is an important principle of



criminal law that serves to ensure that justice is done within a reasonable time and to prevent abuse of legal processes.

However, there is continuous discussion regarding how the statute of limitations for criminal responsibility should be applied in the context of international law. This is because serious crimes such as genocide, crimes against humanity and war crimes may not be subject to the statute of limitations due to their gravity and the need to ensure that those responsible are brought to justice. This paper provides an overview of the statute of limitations in international criminal law, including the different approaches taken by international courts. It examines the tensions between the principles of justice, accountability and legal certainty that underpin the statute of limitations debate. The paper also discusses the impact of the statute of limitations on the ability of international criminal justice to bring perpetrators of international crimes to justice.

The importance of the paper lies in providing knowledge on the challenges and opportunities presented by different approaches to limitation in international criminal law, thus contributing to the development of a sustainable and principled approach that supports the values of justice and accountability. It offers a modest contribution regarding the updating of national literature and Albania's attitude towards the prescription of criminal offenses in international criminal law.

Thesis Title: Reasonable Time and Courts Established by Law in the Constitutional Point of View.

The Impact of the Justice Reform on the Control of Due Process.

Supervisor: Dr. Heliona Miço

Thesis Summary: This paper aims to reflect as clearly as possible the treatment of the current legislation and jurisprudence with reference to the right to due process in its two main aspects, the reasonable time and the courts created by law, as well as it will analyze the impact of the Justice Reform. The paper begins by presenting in a broad way the meaning of the due process, based on both Albanian and international doctrine. The paper will specifically analyze the right to due process enshrined in Article 6 of the European Convention on Human Rights and its jurisprudence, alongside the jurisprudence of the Albanian Constitutional Court, highlighting the evolution of these two aspects of due process. The jurisprudence of the European Court of Human Rights will serve as a reflection for the protection and full realization of the right to a due process of law in the Albanian context.

Thesis Title: An Analysis of the Criminal Offense of Cyber Crime According to International

Standards.

Supervisor: Dr. Alba Gërdeci

Thesis Summary: Technological advancements, especially the advent of the internet, have led to a new era of communication, often referred to as the revolution of the century. This progress not only enables the exchange of information between individuals across vast distances and different countries but also provides a platform for committing criminal offenses when combined with computer systems. Traditional crimes such as theft, fraud, espionage, pedophilia, and terrorism have found new avenues within digital systems. This paper examines the history, definition, and international legislation surrounding cybercrime, with a specific emphasis on the Budapest Convention and the role of NATO in combating these criminal activities. On this regard, certain states affected by cyber-attacks recognize the necessity, in addition to international conventions, for NATO's intervention as a regulatory body for security. This includes the formulation of collective cyber defense policies and the invocation of Article 5 of the NATO treaty. Additionally,



this paper will analyze the cyber-attack in the Republic of Albania that occurred on July 15, 2022. Finally, the challenges related to addressing and preventing cybercrime will be examined, emphasizing the complexity and evolving nature of this global threat. The findings shed light on the urgent need for enhanced cooperation and robust measures to effectively combat cybercrime at both national and international levels.

Thesis Title: Competition Law Challenges Towards the Digital Marketplaces - The Eu Approach Supervisor: Prof. Dr. Endri Papajorgji

Thesis Summary: Online marketplaces' expansion has completely transformed the way in which products and services are traded, benefiting both consumers and companies in a variety of ways. However, the decentralized nature of online markets, the problem of market domination, and the growing use of big data in digital marketplaces, has brought many difficulties related to competition law. Further complicating matters is the growth of platform-to-business (P2B) partnerships. This thesis discusses recent competition cases involving online platforms and offers an outline of the difficulties faced by competition authorities in dealing with competition concerns in digital markets. The specific applicability of Articles 101 and 102 of the Treaty on the Functioning of the European Union to concerns involving digital platforms will be thoroughly examined in the main section. This will be accomplished by going through each stage of the application process and locating the problems. There will also be discussion of potential fixes for the concerns mentioned. The case study of Amazon Marketplace will be done in the thesis' final part in light of an earlier judgment made by the Commission and the German Competition Authority. The study outlines the raised concerns and offers potential solutions. Thus, it will provide a glimpse into a potential future strategy that the European Union competition authorities, including the Commission and National Competition Authorities, may adopt about online platforms.

Thesis Title: Harmonization of the Public Consultation Procedure with Eu Acquis in the Candidate

Countries: The Case of Albania. Supervisor: Dr. Gentjan Skara

Thesis Summary: Albania has consistently taken action to adhere to European values, standards and requirements, all for the ultimate purpose of joining the European Union. As the European Union demands that its candidate countries carry out the obligations imposed for their EU membership, Albania strives to do so in every step of the way as a sign of commitment to its accession. To ensure compliance with EU law in the framework of public consultations, the Albanian government has undertaken several initiatives towards transparency, accountability, openness and engagement of the civil society. This thesis unveils the legal framework regarding the public consultation process as key to public participation, both at the European and Albanian domestic level through the respective rules, procedures and conducting institutions. It analyzes the extent to which Albania has amended its legal framework regulating the public consultation process in light of its EU accession and approximation of its legislation with the EU standards. It explores the public consultation performance at the domestic level and uncovers the challenges of implementing its legal framework.

Thesis Title: Lawsuit on Succession Claim.



Supervisor: Dr. Eglantina Farruku

<u>Thesis Summary:</u> This study examines the succession claim process in Albania, Italy and the region. Due to a long lack of knowledge, cultural diversity and information about this institute, the lawsuit for the succession claim is of particular importance. Inheritance as an institution is treated for the social and legal impact that it has because succession in any form either directly or indirectly affects the rights of current or future heirs.

The lawsuit on the succession claim is an instrument that provides protection for the rights that the heirs have. This is the reason why this lawsuit is implemented differently depending on each country's legislation.

The aim of this study is to recognize the importance of this lawsuit and provide insight on the necessity of the proper court proceedings regarding this claim. It also emphasizes the origin of this lawsuit and the transition that these proceedings have foregone.

Moreover, included in this paper is also the comparative view with the Italian, German, French and Greek legislation which have had a significant influence on the implementation of the Albanian Civil Code, in order to provide a different prospect with those countries alongside the development of the modern Albanian Civil Code.

Thesis Title: A Critique of Purposive and Dynamic Interpretation.

Supervisor: Dr. Bojana Hajdini

Thesis Summary: This paper is concentrated on providing a critical assessment of the two predominant theories of interpretation, purposive and dynamic interpretation, which have gained much traction within the circles of jurisprudence. The core assumption upon which the critique is found is that because these theories endorse some form of departure from the text of the legal documents, the courts that embrace them become entitled to reshape the law and by doing so they intervene with the legislative tasks, which are an exclusivity of the legislative branch. Thus, they create some imbalance between the prerogatives that each of these two branches enjoy. The analysis extends to the accuracy and validity of the central pillars for each approach. Regarding purposive interpretation, it is maintained that the concept of the intent of the legislature as a whole is fictitious and that legislative history, contrary to what is generally acknowledged, cannot reflect intent. Also, as a result of compromises between different groups in the parliaments, laws often serve different interests and functions simultaneously, and therefore establishing one purpose in the light of which to interpret them is erroneous. As for the dynamic interpretation, it is contended that it has no guiding principles on how to estimate in which direction has the law evolved and that despite what is emphasized as a benefit, it does not provide flexibility. Furthermore, it is argued that the only way to repeal old laws is through the legislative process, not by extending the discretion of the judiciary. The conclusion is that both forms have some implications regarding the separation of powers in democratic systems and also, when applied, generate some degree of subjectiveness and arbitrariness.

2022-23 academic year, Fall Semester

Introduction

Following the finalization by the deadline of February 24, 2023, of the grades of courses taught during the 2022-2023 fall semester, the results of the student surveys were published in EIS system. These are compulsory student surveys for assessment of courses and of academic staff at the end of each semester before the students are issued with the final grades.

The courses subject to this assessment are <u>35</u>, out of which:

- 24 courses are offered by the Department of Law to the students of the integrated second cycle study program in Law (PICD Law);
- 7 courses are offered by the Department of Law to other Bachelor study programs of FEAS, FLSS and FAE:
- 4 courses are offered by course instructors from other Departments to the students of PICD Law;

The response rate to this survey was very high; the lowest percentage concerning the response rate has been 94.12% and the highest ones 100%.

The results of the survey show in general a very positive assessment of the LAW courses and of its academic staff members.

The highest scoring course was 3.94 out of 4.00 and the lowest one was 3.12 out of 4.00 points.



Open lecture by Prof. Dr. Gentian Zyberi on the practice of the UN Human Rights Committee, especially during the period 2019-2022



On May 24, 2023, we had the honor to welcome on the University campus Prof. Dr. Gentian Zyberi. Professor Zyberi works in the area of International Law and Human Rights, at the Norwegian Center for Human Rights, University of Oslo. He has been a member of the United Nations Human Rights Committee (2019-2022) and the Permanent Court of Arbitration (2016-2028). He is the President of the Albanian branch of the International Law Association. He has published several books and about 70 articles and book chapters in various fields of international law. His latest edited volume deals with the protection of community interests under international law.

In this open lecture, Professor Zyberi explained the practice of the Human Rights Committee, which monitors the observance by the 173 State parties of important civil and political rights included in the International Covenant on Civil and Political Rights (ICCPR). As a former member of the Committee (2019-2022) and familiar with its work, he explained the Committee's working methods and its contribution to the development of international human rights law more generally. This practice is very important for Albania, as a State party to the ICCPR since 1992.

The lecture was addressed to the students of the Law and Political Science and International Relations Departments, in particular those enrolled in the course Public International Law. The lecture was followed by a Q&A session.

Dr. Heliona Miço participated in teaching mobility in the framework of the Erasmus+ Programme at the University of Salerno, Italy.





During July 10-14, 2023, Dr. Heliona Miço participated in Teaching Mobility program in the framework of the Erasmus+ International Credit Mobility (ICM) Agreement signed between EPOKA University and the University of Salerno (UNISA) in Italy.

Dr. Miço shared her professional experience by pointing out the changes in Albanian legislation to create training courses of excellence in accordance with European Union standards in the adaptation of teaching programs. Dr. Miço illustrated the right to education in international and European law, explaining the reforms adopted in Albania to complete the EU standards. She explained the activities carried out at Epoka University in professional training in collaboration with ELSA Albania.

This was followed by a meeting with Albanian students Andrea Kokomeci and Egla Leci to discuss their degree dissertations respectively on the impact of EU commercial law on Albania's economic transformation and the evolution of Albanian data protection legislation in comparison to the EU GDPR. As supervisors of the dissertations of the two Albanian students, Dr. Heliona Miço and Prof. Teresa Russo discussed the contents of the works in detail, providing hints and suggestions to highlight how Albania is dealing with the adaptation to the EU acquis in these two areas.

Participation in the ATEE – ELTE Annual Conference "Teacher Education on the Move"





Dr. Heliona Miço, lecturer of public law at Epoka University participated on 27-30.08.2023 at the ATEE – ELTE Annual Conference "Teacher Education on the Move" - Budapest, 27-30 August 2023, organized by ATEE (Association for Teacher Education in Europe) and ELTE University, Budapest, Hungary, with the paper "Legal issues of Roma inclusion in education in Western Balkan Countries".

This paper presents an overview of the legal concerns on teacher education in relation to alleviating discrimination against Roma children. The research identifies the problems encountered in the framework of discrimination of Roma children in education and the need for a better legislative and political framework, towards approximation with European standards. The paper is devoted to the analysis of teacher education for Roma children in Western Balkan countries, evidencing the common challenges and problems that these countries have, with the aim of achieving more efficient implementation of inclusive education at the national level.
