## **A. Organization & Management**

### **Introduction**

Based on the Ordinance of the Minister of Education and Sports No. 116, dated 13.03.2017 "On the opening of the main unit and the institutional re-organisation of Epoka University", starting from the 2017-2018 academic year, the Department of Law has been established as part of the Faculty of Law and Social Sciences. It started its academic activities during the 2018-2019 academic year by building upon the solid academic tradition of EPOKA University.

The mission of the Department of Law, through the integrated second cycle program in Law is to prepare specialists in the field of law, future qualified leaders to contribute in the advancement of justice and the welfare of society; capable to engage in position in the judiciary, juridical bodies, prosecution, advocacy, notaries, bailiff, arbitration, central and local state administration, various institutions of state authorities, as well as in private sector.

Our integrated second cycle study program is the only bilingual Law program in the country with English and Albanian as languages of instruction, and it has a strong emphasis on International and EU Law. The curriculum of the program has an inter-disciplinary approach with courses offered in collaboration with the other Departments from the Faculty of Law and Social Sciences as well as from the Faculty of Economics and Administrative Sciences.

Our students will have the opportunity to be participate in numerous mobility programs in the framework of Erasmus+ program as well as other bilateral agreements. They will also have the chance to experience the rich campus life at EPOKA and benefit from the internship programs.

The Department is committed to be an active unit which aims to resolve legal, social, economic, domestic and international political problems that are of a particular interest to society.

## **Study programs offered by the Department**

Department of Law offers only one study program, the integrated study program in Law.

Pursuant to the Ordinance of the Minister of the Education, Sports and Youth No. 412, dated 18.09.2017, the Integrated second cycle study program in Law to be offered by the Department of Law under the Faculty of Law and Social Sciences of EPOKA University has been licensed.

The Integrated second cycle study program in Law is a full-time study program, with a duration of 5 (five) academic years with 300 ECTS, and it is a bilingual program with Albanian and English as languages of instruction.

The study program enrolled its first cohort during the 2018-2019 academic year.

The integrated second cycle study program in Law offers to students the opportunity to gain analytical capacities and the basic concepts of law, legal terminology, legal theories and necessary procedures to deal with the theoretical and practical problems in the field of law.

The integrated second cycle study program in Law offered by our Department is in full compliance with the requirements of the Albanian Higher Education Law and after the completion of this 5-year program, students are conferred a Master of Science degree.

Students who graduate from the integrated second cycle study program in Law can become judges, prosecutors, lawyers, notaries, state lawyers, private or state bailiffs, as well as lawyers in the central and local state administration, after they have completed the state exam in law.

#### **Acting Head of the Department**

Niuton Mulleti was born in Shkodër, Albania, in 1981. With a Bachelor and Master's degree in International Relations awarded respectively by Gazi University in Ankara, Turkey, and Central European University in Budapest, Hungary, from 2004 to 2008, he worked at the (Central) Bank of Albania, firstly as a Specialist and then as Head of Division covering issues related to Bank of Albania's foreign relations as well as European Integration, with a particular focus on the approximation of Bank of Albania's legislation and procedures with the *acquis communautaire*. Since November 2008, Mr. Mulleti has been working at Epoka University initially as Head of the Rector's Cabinet and since 2017, as Head of the Institutional and Legal Affairs Office. Mr. Mulleti is also a Lecturer at the Department of Political Science and International Relations of Epoka University. In 2016 he completed his PhD degree in International Relations and Diplomacy at the HEIP-Centre d'Etudes Diplomatiques et Strategiques (CEDS) in Paris, France. His research interest areas are Theories of International Relations, EU Foreign and Defence Policy and EU Law.

Dr. Gelanda Shkurtaj is an academic lawyer and public notary, living in Tirana (Albania). She accomplished the full Masters' Degree diploma in Biology at Tirana University in 1997. During 2002-2011 she worked as a Court Expert and Technical Adviser at the General Prosecutor's Office in Liguria Region (Italy) and simultaneously she obtained the second full Master's Degree diploma in Law, in 2009. In 2011 she obtained an LLM in international and national Taxation Law, at Genoa University. In 2012 she moved to Abruzzo Region (acting as a managing authority) in Italy, where she kept the position of Senior Project Manager of E.U.Funds (Instrument of Pre-accession), Cross Border 2007-2013 Program. She won the public competition and established her notary office in Tirana in 2013. During the years 2013-2017 she held the position of Adjunct Lecturer of Fiscal and Taxation Law at New York University in Tirana. In 2018 she obtained the PHD in Legal Anthropology at the Academy of Albanological Studies. Since October 2016, she kept the position of Introduction and Business Law adjunct lecturer, and since October 2018 she is a full time lecturer at "Epoka" University, in Roman, Civil and Taxation Law.

Dr. Alba Gerdeci has been working at Epoka University, in Tirana, Albania, as of 11 years, holding various administrative positions. As of 2013, she has directed the International Relations Office, drawing, negotiating and ensuring implementation of international agreements with partner institutions in different parts of the world, particularly those located in Europe, US and Canada. During the time in office, she has managed communication with more than a hundred partner institutions, processed around 150 student exchange programs and 150 staff exchange programs. As of 2017, she has been assigned at the same time as the

Head of Rector`s Cabinet, responsible for contributing to the proper conduct of both internal and external communication, as well as ensuring the compliance of all acts, documents and operations of the University with both the national legislation on higher education as well as with the legal acts of the University.

Dr. Alba Gerdeci received her Ph.D. in International Relations from the University of Tirana in 2019. She has a Master of Second Level in Business Administration from Epoka University and an Integrated Diploma in Law from the Faculty of Law, University of Tirana. As of 2010, she has been teaching law courses at the undergraduate level delivered to non-lawyer audiences such as: Introduction to Law, Business Law, International Law and Constitutional Law. The language of instruction of these courses was English. During the 2018-2019, she was responsible to deliver the Criminal Law course at the newly established Law Department of Epoka University.

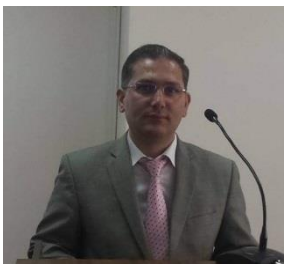

#### **1. Participation in Academic Events**

##### **1.1 Participation at the kick-off meeting of the COST Action “Constitution-making and deliberative democracy”**



During January 30 – February 1, 2019, Ms. Alba Gerdec, lecturer at the Department of Law participated on behalf of Epoka University at the kick off meeting of the COST Action “Constitution-making and deliberative democracy”. The aim of this action is to bring together all actors to discuss and reflect on deliberative democracy experiments, with particular focus on the role of the citizenry regarding constitutional changes, which traditionally are the sole responsibility of elected officials, in collaboration with experts.

During the activity, Ms. Gerdec shared with members of the network, the Albanian legal framework regarding political participation, constitutional changes and referendums, highlighting some of the recent initiatives of the government to enhance citizens participation in decision-making such as the Open Governance Partnership in 2011, approval in the 2014 of the Law on the Right to Information and Law on Notification and Public Consultation and the E-governance platform.

This Action is chaired by Université catholique de Louvain.



### **1.2 Dr. Niuton Mulleti participated at the 2019 CEU Erasmus+ International Staff Training Week**



During May 06-10, 2019, Dr. Niuton Mulleti participated at the 2019 Erasmus+ International Staff Training Week organized by the Central European University (CEU) in Budapest, Hungary in the framework of the Erasmus+ mobility agreement signed between EPOKA University and CEU.

The International Staff Training Week began with an introduction to higher education in Hungary, and internationalisation practices. Participants were also provided with extensive information about CEU and the latest institutional developments.

The second day of the event focused on external pressures – attacks on academic freedom and ways to face them, as well as on the costs and benefits of the internationalisation of universities. Experienced CEU officers shared their experience on how to keep calm and grounded in times of turmoil, and how to turn challenges into opportunities concerning the internationalisation of universities.

The third day focused on participants' professional development as international educators in the form of an intercultural communication training, whereas the following day was devoted to Erasmus+ operational questions, partnership building, and the international student cycle aiming at ensuring a great student experience.

The program included presentations and group discussions lead by CEU experts, as well as invited guest speakers. The last day of the program was devoted to meetings between participants and their counterparts at CEU aiming at sharing experiences and exchanging best practices in the respective areas.

### **1.3 Dr. Gelanda Shkurtaj gives an open lecture to master students of "La Sapienza" University, Rome**

On Friday, June 14th, 2019, Dr. Gelanda Shkurtaj, lecturer of Department of Law, representing "Epoka" University, had the opportunity to give an open lecture to the master students of University of La Sapienza, Rome, via skypecall. Topics discussed were regarding Albanian tax law. Dr. Shkurtaj had a very interactive discussion with Italian students, who seemed very interested in the topics. At the end of the lecture, both parties expressed the interest to have more cooperations of the same type in the future.

### **1.4 Dr. Gelanda Shkurtaj at ASEAN PPP Summit: PPP 2019**

Dr. Gelanda Shkurtaj was part of ASEAN PPP Summit: Public-Private Partnership 2019 held in Bangkok at June 16, 2019. She participated with the titled "Public and Private Partnership in Albania. The Legal Framework from The Legislative Provisions to the Risk of Management", abstract of which is written below:

**PUBLIC AND PRIVATE PARTNERSHIP IN ALBANIA. THE LEGAL FRAMEWORK FROM THE LEGISLATIVE PROVISIONS TO THE RISK OF MANAGEMENT**

**Abstract**

Public Private Partnerships (PPPs) are frequently used in Albania, mainly in the form of concession, as the "engine" to make work the public sector in the field of investments. It is estimated that recently, there are more than 170 PPP-s only in the infrastructure sectors in Albania. The focus in this policy was given by the European Union, and the process is based in a legal framework, which, in few years has been amended frequently with the aim to make increase the investments fields, stakeholders and benefits. It is to be emphasized that Albania has set up an ad hoc public institution, called the "Agency on the Treatment of Concessions".

There are examples of PPP-s contracted and implemented in Albania, considered as success story, but studies revealed that they lack of specific comparative analyses in Value for Money with public procurement, social assessment and high critical risks in 'corruption and lack of "respect of law"'. The old rules of controlling the PPP-s implementations are no more correctly applying. The PPP-s mechanism now is being used as a method to sustain government corruption through the partnership with private investors which are closed to the main political force or alley. The main problem stands at the fact that, throw this mechanism the government is stipulating contracts on infrastructure, including areas which are part of the historical inheritance. It is needed a strong

legal framework, where should not be allowed the interference of the political interest, which by using this means not only charges the state budget and the economy, but can be even a precedent on misusing the inheritance and public economy for small group of interests.

### **1.5 Dr. Gelanda Shkurtaj at 7th International Conference on Sustainable Development, Rome**

Dr. Gelanda Shkurtaj participated at 7th International Conference on Sustainable Development, held in Rome, Italy at 4-5 September, 2019 with a paper titled “Kanuns in Albania and bloodfeud according to Kanun of Lekë Dukagjini”.

#### **Abstract**

In societies where it has been known and applied, bloodfeud is described as a possibly outdated and uncivilized mechanism, but often effective to limit violence. Indeed, both in form and substance the phenomenon itself is hard to be perceived and understood by the modern citizen of every country of the world, including Albania, where it is still active in some regions in respect of “Kanun”. In fact, the Albanian term 'Kanun' describes the body of traditional norms/standards and rules governing society in the field of criminal, civil and procedural laws. Its application or merely its existence in moral and legal standards makes a society safer, certainly referring to a society where the power of central authority, namely of the state, either did not exist or lacked. The greatest anthropological dilemma is just there, why does Kanun work in a modern state? In societies where blood feud has been present as a regulatory element of social conflicts it is accepted that its abolition or decline occurred only when another subject (the state), took over to intervene in these conflicting relationships, and to provide the resolution and regulation of social and economic relations through enforcement of rule of law, or the public order. And the question arises by itself: why the Albanian state did not take over the blood feud solution by use of public order? The Kanun does not recognize the state or the state does not recognize the Kanun? Why? It is not easy to get into such historic and social dilemmas, but a modest effort should be made. The answer to this fact should be found by the history of Albania. As a questioning remark, the reason for the long life of Kanun, rather called as self-regulatory law of the society, is due to the historic absence of a state on the side and interests of its citizens.

## 2. Events organized for the students of Law

### 2.1 Peace Forum: Debating Europe 100 Years after World War I



Peace Forum: Debating Europe 100 Years after World War I

The Faculty of Law and Social Sciences has organized today the **University Peace Forum** titled “**Debating Europe 100 Years after World War I**”. One century ago, the world was transformed by one of the most notorious events to take place in the history of mankind: World War I. Europe was a battlefield where the military, the political and social all clashed with each other, altering the dynamics in the international arena and leaving behind an ongoing legacy. Today we commemorate the centenary of this Great War and its legacy which will continue to shape the future of Europe and world politics.

We had the pleasure to have among us, **Prof. Dr. Georg Kastner**, Chair of Central History, University of Andrassy Budapest and two graduate students from Epoka University, Sara Malosmani and Ines Stasa. This forum was chaired by Assoc. Prof. Dr. Lisen Bashkurti, Dean of Faculty of Law and Social Sciences. Prof. Bashkurti, a well-known expert on diplomacy and peace addressed the audience with his speech on “History of War and Diplomacy of Peace”. Prof. Bashkurti highlighted the major events that led to the beginning of the WWI, along with influential states that shaped history. The Treaty of Versailles, “Europe of Peace” and “EU Project”, were heavily discussed as European ideas of peace. Prof. Bashkurti concluded with one final remark “*History is the living past and is very much present in our lives*”.

The other part of the discussion was followed up by Prof. Dr. Georg Kastner, keynote speaker at the forum. Prof. Kastner based his remarks in three keynote questions:

- 1- Is there a system of relations between Southern and Eastern countries?
- 2- How are these relations described nowadays?
- 3- Have these relations increased or stagnated?

The professor brought us the experiences of war and peace of Central European countries and concluded by reference to the relations with European Union.

Throughout the last century students of Political Science and International Relations have also sought to understand and explain what World War I brought to the international system and contributed via their studies to a more sustainable and peaceful world system. In this regard, the forum involved the works of two graduate students from the department of Political Science and International Relations.

Sara Malosmani, master student and teaching assistant at Epoka University discussed the position of Albania during the WWI and Ines Stasa, PhD student, explained the importance of legitimacy and power in terms of order and peace, predictability and understanding the issue in the Balkans. The forum concluded with the final remark that history repeats itself and it is important to draw out lessons from it.
