## A. Organization & Management

### Introduction

Based on the Ordinance of the Minister of Education and Sports No. 116, dated 13.03.2017 "On the opening of the main unit and the institutional re-organisation of Epoka University", starting from the 2017-2018 academic year, the Department of Law has been established as part of the Faculty of Law and Social Sciences. It started its academic activities during the 2018-2019 academic year by building upon the solid academic tradition of EPOKA University.

The mission of the Department of Law, through the integrated second cycle program in Law is to prepare specialists in the field of law, future qualified leaders to contribute in the advancement of justice and the welfare of society; capable to engage in position in the judiciary, juridical bodies, prosecution, advocacy, notaries, bailiff, arbitration, central and local state administration, various institutions of state authorities, as well as in private sector.

Our integrated second cycle study program is the only bilingual Law program in the country with English and Albanian as languages of instruction, and it has a strong emphasis on International and EU Law. The curriculum of the program has an inter-disciplinary approach with courses offered in collaboration with the other Departments from the Faculty of Law and Social Sciences as well as from the Faculty of Economics and Administrative Sciences.

Our students will have the opportunity to be participate in numerous mobility programs in the framework of Erasmus+ program as well as other bilateral agreements. They will also have the chance to experience the rich campus life at EPOKA and benefit from the internship programs.

The Department is committed to be an active unit which aims to resolve legal, social, economic, domestic and international political problems that are of a particular interest to society.

## **Study programs offered by the Department**

Department of Law offers only one study program, the integrated study program in Law.

Pursuant to the Ordinance of the Minister of the Education, Sports and Youth No. 412, dated 18.09.2017, the Integrated second cycle study program in Law to be offered by the Department of Law under the Faculty of Law and Social Sciences of EPOKA University has been licensed.

The Integrated second cycle study program in Law is a full-time study program, with a duration of 5 (five) academic years with 300 ECTS, and it is a bilingual program with Albanian and English as languages of instruction.

The study program enrolled its first cohort during the 2018-2019 academic year.

The integrated second cycle study program in Law offers to students the opportunity to gain analytical capacities and the basic concepts of law, legal terminology, legal theories and necessary procedures to deal with the theoretical and practical problems in the field of law.

The integrated second cycle study program in Law offered by our Department is in full compliance with the requirements of the Albanian Higher Education Law and after the completion of this 5-year program, students are conferred a Master of Science degree.

Students who graduate from the integrated second cycle study program in Law can become judges, prosecutors, lawyers, notaries, state lawyers, private or state bailiffs, as well as lawyers in the central and local state administration, after they have completed the state exam in law.

Dr. Niuton Mulleti

#### **Acting Head of the Department**

Niuton Mulleti was born in Shkodër, Albania, in 1981. With a Bachelor and Master's degree in International Relations awarded respectively by Gazi University in Ankara, Turkey, and Central European University in Budapest, Hungary, from 2004 to 2008, he worked at the (Central) Bank of Albania, firstly as a Specialist and then as Head of Division covering issues related to Bank of Albania's foreign relations as well as European Integration, with a particular focus on the approximation of Bank of Albania's legislation and procedures with the *acquis communautaire*. Since November 2008, Mr. Mulleti has been working at Epoka University initially as Head of the Rector's Cabinet and since 2017, as Head of the Institutional and Legal Affairs Office and Acting Head of the Department of Law. Mr. Mulleti is also a Lecturer at the Department of Political Science and International Relations of Epoka University. In 2016 he completed his PhD degree in International Relations and Diplomacy at the HEIP-Centre d'Etudes Diplomatiques et Strategiques (CEDS) in Paris, France. His research interest areas are Theories of International Relations, EU Foreign and Defence Policy and EU Law.

Dr. Gelanda Shkurtaj is an academic lawyer and public notary, living in Tirana (Albania). She accomplished the full Masters' Degree diploma in Biology at Tirana University in 1997. During 2002-2011 she worked as a Court Expert and Technical Adviser at the General Prosecutor's Office in Liguria Region (Italy) and simultaneously she obtained the second full Master's Degree diploma in Law, in 2009. In 2011 she obtained an LLM in international and national Taxation Law, at Genoa University. In 2012 she moved to Abruzzo Region (acting as a managing authority) in Italy, where she kept the position of Senior Project Manager of E.U.Funds (Instrument of Pre-accession), Cross Border 2007-2013 Program. She won the public competition and established her notary office in Tirana in 2013. During the years 2013-2017 she held the position of Adjunct Lecturer of Fiscal and Taxation Law at New York University in Tirana. In 2018 she obtained the PHD in Legal Anthropology at the Academy of Albanological Studies. Since October 2016, she kept the position of Introduction and Business Law adjunct lecturer, and since October 2018 she is a full time lecturer at "Epoka" University, in Roman, Civil and Taxation Law.

Dr. Alba Gerdeci has been working at Epoka University, in Tirana, Albania, as of 11 years, holding various administrative positions. As of 2013, she has directed the International

Relations Office, drawing, negotiating and ensuring implementation of international agreements with partner institutions in different parts of the world, particularly those located in Europe, US and Canada. During the time in office, she has managed communication with more than a hundred partner institutions, processed around 150 student exchange programs and 150 staff exchange programs. As of 2017, she has been assigned at the same time as the Head of Rector`s Cabinet, responsible for contributing to the proper conduct of both internal and external communication, as well as ensuring the compliance of all acts, documents and operations of the University with both the national legislation on higher education as well as with the legal acts of the University.

Dr. Alba Gerdeci received her Ph.D. in International Relations from the University of Tirana in 2019. She has a Master of Second Level in Business Administration from Epoka University and an Integrated Diploma in Law from the Faculty of Law, University of Tirana. As of 2010, she has been teaching law courses at the undergraduate level delivered to non-lawyer audiences such as: Introduction to Law, Business Law, International Law and Constitutional Law. The language of instruction of these courses was English. During the 2018-2019, she was responsible to deliver the Criminal Law course at the newly established Law Department of Epoka University.

Her research areas include human rights, international law, humanitarian intervention, responsibility to protect and the United Nations.

### **1.2 Dr. Gelanda Shkurtaj gives an Open Lecture to the Master Student Of University of La Sapienza, Rome**

The professor of the department of Law, Faculty of Law and Social Sciences at “Epoka” University”, Dr. Gelanda SHKURTAJ for the second year, was invited by the University “La Sapienza” -Rome (Italy), to give an open lecture on the: “Taxation in the East Europe and in Balkans”. The interested group, were the students of the program “Master in Tax Law”, at the Faculty of Political Science of the same University, under the direction of Prof. Dr. Pietro SELICATO, as well as the attorney at law, Dr. Vincenzo CARBONE. The lecture given by professor SHKURTAJ, was focused on the Constitutional guiding principles in the field of taxation in Albania, the content of the Tax Code in Albania (the law on “Tax Procedures n.9920/2008”), the main taxes and procedures for their collection. The whole lecture was described through a comparative methodology, between Italian and Albanian tax systems, giving students the opportunity to know concretely the Albanian tax system. The lesson had a very enthusiastic support and a very positive impact regarding the recognition of a relatively new system, as well as the recognition of tax practices in Albania, as a part of East Europe. Also the lesson was considered as satisfying to their curiosity about low taxation in Albania and the possibility of conducting investments in the future. They recently thanked for the opportunity given.

On November 15, 2019 the Roundtable debate on Planning and Enhancing EU-Western Balkans Cooperation on Justice and Home Affairs (JHA) was held at EPOKA University in the framework of the Jean Monnet Module titled “EU-Western Balkans Cooperation on Justice and Home Affairs” (EUWEB), managed by the University of Salerno (UNISA) in Italy where EPOKA also participates as a partner institution.

## 2.4 Open Lecture: Vetting of Judges and Prosecutors in Albania, Legal Framework and Opinions on Vetting Practice so far

On January 15, the Center for European Studies and the Department of Law welcomed Ms. Erinda Skendaj, the executive director of the Albanian Helsinki Committee. The open forum's main theme focused on the vetting of judges and prosecutors in Albania. More specifically, the forum shed light into the legal perspective and the evaluation of progress by Ms. Skendaj.

In autumn 2014 the European Commission's Progress Report highlighted several times in a row the need for concrete interventions in the judiciary, as a measure to fight the high level of corruption in the system. Thus, the Albanian Assembly established the Special Parliamentary Commission on the Judicial Reform, which prepared the main analytical document underlining numerous problems in the judiciary, and emphasizing the necessity of legal amendments with the functioning and consolidation of the rule of law as its final aim. The high level of corruption in the judiciary impedes its functioning and has affected the public trust toward it. At the same time, this situation has prevented further progress in terms of the European integration of the country. Three out of five priorities set by the European Commission were related to the judiciary. Namely, these priorities were the reformation of the judiciary, the fight against corruption and the protection of human rights and fundamental freedoms.

The forum started by a brief introduction by Ms. Skendaj of the Reform on Justice. Later on, she passed into a more in-depth explanation of the vetting process and the steps taken by the Albanian Helsinki Committee and the Albanian government. In addition, Ms. Skendaj carefully explained how certain processes did not fully accomplish themselves but as she later on said, the overall goal has accomplished much more important than certain technicalities. As the forum approached its end, students of Political Science and International Relations and students of Law started a fruitful and unfortunately unfinalized with Ms. Skendaj. The questions and comments from the audience upheld and maintained a good quality discussion. As she writes in her LinkedIn profile, "It was a pleasure to be part of the open lecture with the students of Epoka University and to discuss with them the vetting process of judges and prosecutors in Albania. Vetting is a very valuable and also

complex process that in my perception has achieved some very good results, despite some challenges that need to address better. I was surprised about the interest and very technical questions addressed by students on this topic, indicating their high level of knowledge on legal issues. I hope that the new generation of lawyers in Albania will be a very good example of integrity, in our society and especially in the Justice System. On the other hand, we have to acknowledge the professional and moral integrity of several judges and prosecutors who are in the existing system and should be promoted with meritocracy”.

We are highly thankful of Ms. Skendaj for joining us on that day and we wish for more fruitful forums like this to come!
